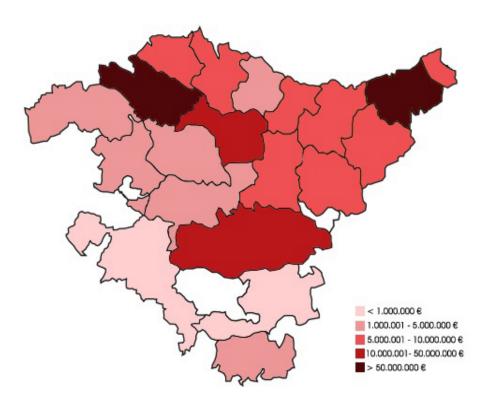

Distribution of the level of consolidated expenditure on culture of city councils according to administrative grouping of municipalities.

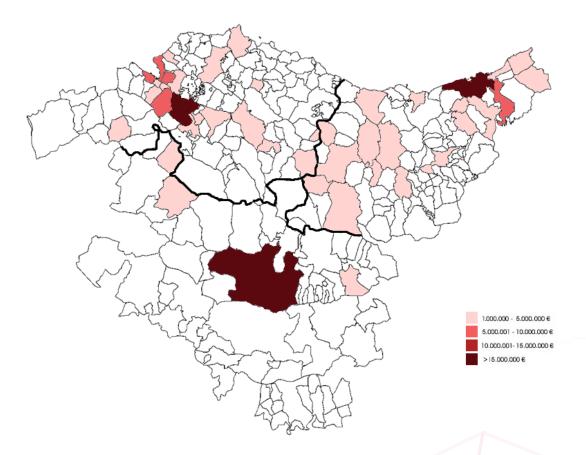
